

Biennial License Renewal Transition

Resident or Non-Resident Insurance Agent (Limited Line of Authority)

Renewed or Issued on or after September 1, 2010

Resident or Non-Resident insurance agents who hold an active license with a limited line of authority as of September 1, 2010 or after, shall renew their license by the last day of their birth month. No transition period shall be less than 18 months nor more than 29 months from license issuance date. On-going renewal periods shall be the last day of their birth month every two years thereafter.

(Exception: If an individual also holds another active license with a Major LOA, the renewal cycle will be established by the Major LOA.)
