

Biennial License Renewal Transition
Individual Resident Agent License (Major Line of Authority or Title)
Issued On or After January 1, 2010

Individual RESIDENT insurance agents who are issued a license with a major line of authority or title on or after January 1, 2010, shall renew their license by the last day of their birth month. No transition period shall be less than eighteen months nor more than twenty-nine months from license issuance date. On-going renewal periods shall be the last day of their birth month every two years thereafter.

* Resident individual agents have a CE credit requirement of 24 credits (3 of which must be approved as ethics) prior to license renewal. Title agents will be required to complete Title specific CE credits pursuant to Ohio Administrative Code 3901-5-01 (D) prior to renewal of the license.
